#### **MISSION:**

#### **What is coming up new and exciting with your organization?**

We are currently preparing for our 9<sup>th</sup> Annual Performances, “Dance for Today,” which will be held on May 7, 2016 and several fundraisers: a Bowlathon & Golf Tournament.

#### **What is the time commitment?**

We have a minimum 8 annual meetings, typically once a month on alternating Mondays & Thursdays at 6pm for about 1.5 hours. (Subject to change) There is a two-year term-limit for each seat on the Board of Directors.

#### **Are there additional time commitments outside of the monthly meetings?**

Yes, there are possible committee meetings. Board members are expected to volunteer for a committee, attend at least one fundraiser and attend / participate in the performances (May). New board members may also be interested in volunteering for a class during the summer session (July-August) or the full dance season (September – May).

#### **Do you have an orientation process for new board members?**

Yes, there will be an orientation in July for new members to learn more about the organization and what we do as a Board.

#### **Is there a monetary commitment expected of the board members?**

As with most boards, it is important in order to receive grant funding to have 100% giving on the board; whatever personal financial contribution you feel appropriate. Board members are also expected to sell tickets for our events and secure donations when possible. As always, finding financial donors is a key duty.

#### **What specific needs are you looking to fill on the Board of Directors?**
